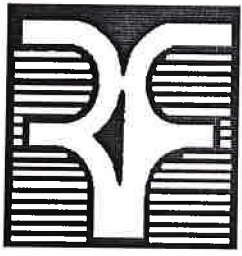
**Subject: Intimation of 30<sup>th</sup> Annual General Meeting, Book Closure and E-voting and attendance through VC/ OAVM facility**

Pursuant to the provisions of Section 108 of the Companies Act, 2013 and Rules framed thereunder, as amended from time to time and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to offer e-voting facility to the Members through Link Intime India Private Limited (LIPL) to exercise the right to vote by electronic means on all Resolutions proposed to be considered at 30<sup>th</sup> Annual General Meeting and the business may be transacted through e-voting facility.

The Cut-off date has been fixed as **Friday, September 11, 2020** for determining the eligibility of the Members to vote by remote e-voting or by e-voting at 30<sup>th</sup> Annual General Meeting.

The detailed instructions for e-voting facility are mentioned in the Notice of 30<sup>th</sup> Annual General Meeting.

The remote e-voting shall commence on **Tuesday, September 15, 2020 at 09:00 a.m. IST** and shall end on **Thursday, September 17, 2020 at 05:00 p.m. IST**.
